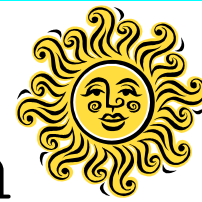

## **BINGO**

I am in the process of renewing our Bingo license for 2010. To do so, I must turn in a list of people who are authorized to work Bingo for Splash. So, if you have someone **OTHER** than yourselves, or your swimmer who will be helping with your bingo commitments (other children over 14, aunts, uncles, grandparents, etc), who are **NOT** already on the bingo schedule, please email the names that you would like listed (first and last, please). I need this information no later than December 10th.

Please note: in the Splash bingo handbook it specifically states that a **parent** must be present along with any other family member to work-- this includes swimmers-- you cannot send your swimmer and/or a sibling to work bingo without you being present as well .

ALSO-If your last name (or the last name of anyone listed to work bingo to fulfill your family's commitments) is different than that of your swimmer, please send me that information. The Secretary of State requires that the names on the list match your government issued ID.

DID YOU KNOW? It is a state regulation that all bingo workers have a photo ID on them when working Bingo. So, don't forget your ID!
